 - ✓ BETWEEN THE 12TH DAY PRECEDING A NOMINATING EVENT;
 - ✓ BETWEEN THE 12TH DAY PRECEDING A NOVEMBER ELECTION AND THE ELECTION DATE; OR
 - ✓ BETWEEN THE 11TH DAY PRECEDING ANY OTHER ELECTION IN WHICH THE INDIVIDUAL IS A CANDIDATE AND THE ELECTION DAY.

- ✓ THE REPORT IS NOT REQUIRED FOR CANDIDATE'S WHO ARE RUNNING UNOPPOSED IN A NOMINATING EVENT.

- ✓ IF THE CONTRIBUTION IS RECEIVED WITHIN THE 24-HOUR PERIOD BEFORE ELECTION DAY, IT MUST BE REPORTED AND THE REPORT MUST BE RECEIVED ON THE DAY BEFORE THE ELECTION.

- ✓ ANY CONTRIBUTION REPORTED AS A LARGE PRE-ELECTION CONTRIBUTION MUST ALSO BE REPORTED ON THE REPORT DUE IMMEDIATELY FOLLOWING THE ELECTION.
